ISTANBUL SEISMIC RISK MITIGATION AND EMERGENCY PREPAREDNESS PROJECT GENERAL PROCUREMENT NOTICE FOR CONSULTANCY, WORKS AND GOODS CONTRACTS

The Republic of Turkey has applied for a loan from the KFW Development Bank for the amount of EUR 250 million for a continuous support of the **Istanbul Seismic Risk Mitigation and Emergency Preparedness Project**. It is foreseen to use the proceeds of this loan for payments of goods, works and consulting services which will be procured using World Bank Procurement Procedures. The project will include the following components:

- Component A: Enhancing Emergency Preparedness
 - Upgrading of Emergency Communication System
 - Disaster Management Information System
 - Support to Develop Operational Capability for Governor's Disaster Management Center (AYM)
 - Upgrading Emergency Response Capacity
 - Materials and Equipment for Public Awareness Campaign
 - Materials and Equipment for Neighborhood Volunteers

- Component B: Seismic Risk Mitigation for Priority Public Facilities
 - Minor Works for the DMCs
 - Reconstruction of Hospitals and Clinics
 - Strengthening of Hospitals and Clinics
 - Retrofitting of Public Schools
 - Reconstruction of Public Schools
 - Retrofitting/Reconstruction of Essential Administrative Buildings
 - Retrofitting/Reconstruction of Dormitories and Social Service Buildings
 - Consultancy Services for Design, Implementation and Dissemination of Training Modules, Materials and Public Awareness Campaigns for Disaster Preparedness
 - Capacity Building Activities to Support İstanbul DMC (Establishment of Voluntary System, Disaster Management Plans and Drills, ISO Standards, E-learning, Media Relations, etc..)
 - Workshops, seminars, symposiums, trainings
 - Preparation of Design for Strengthening/Reconstruction of Key Facilities and Supervision of Retrofitting/Reconstruction Works

The project is expected to be implemented during the period 2016 to 2021 in Istanbul.

Procurement

Procurement of contracts financed by the loan will be conducted through the procedures specified in *World Bank (IBRD/IDA) Guidelines for the procurement of goods, works and services*, and is open to all bidders from eligible source countries as defined in the guidelines.

Specific procurement notices for contracts to be bid under International Open Tender procedures and for large-value consultants' contracts will be announced, as they become available, in Germany Trade & Invest

(GTAI) for the purpose of market information as well as Official Gazette and/or national newspapers and/or free accessible on the web site of Istanbul Project Coordination Unit: www.ipkb.gov.tr
